# AGSC: Priority 1 - Update 2023-2024



## Host the 6th Annual Achieve Transfer Student Success Conference

The 6th Annual Achieve Transfer Student Success Conference took place on March 27-28, 2024, at the University of South Alabama, with Bishop State Community College and Coastal Alabama Community College serving as co-hosts. The majority of the conference sessions were held at the University of South Alabama, while the opening night reception took place on the Bishop State campus.

### Conference Summary

Out of the 247 individuals who registered for the conference, 212 attended, including speakers, exhibitors, sponsors, and participants. This year's event featured four plenary sessions and three concurrent sessions. We had ten sponsors and sixteen exhibitors. Feedback collected from attendees and sessions has been overwhelmingly positive.

### Funds Raised for Transfer Scholarship

Following the conference, the University of South Alabama raised over \$8,000 for the Erin and Joshua E. Cogswell Endowed Scholarship fund after covering all event expenses.

### Planning for the 2025 Achieve Conference

We have not yet finalized the date or host site for the 2025 Achieve Conference. We are currently in the early planning stages and aim to set a date and secure a host institution in the coming weeks.

### ACHIEVE Conference Planning Committee

The 2025 Achieve Conference Planning Committee will commence monthly meetings starting in September of 2024. # AGSC: Priority 2 - Update 2023-2024



## Evaluate and analyze AP & CLEP Credit in an effort to ultimately create a useful crosswalk matrix to bring attention to and address possible issues or problems.

Over the past 4-5 years, the AGSC have been advocating for a standardized acceptance of AP test scores of “3” across all institutions in Alabama. This change aims to streamline the transfer of AP credits, making the process more efficient for students, advisors, counselors, and administrators.

Three years ago, the Alabama General Studies Committee (AGSC) formed an AP sub-committee to address this issue and develop a recommendation for a statewide AP score of “3” for credit transfer. This recommendation was finalized in April of 2021 and submitted to the Council of Chief Academic Officers (CCAO) through a formal letter from the AGSC Chair.

### AP Credit Recommendation from the AGSC to the Council of Chief Academic Officers

1. *Disciplinary experts at each institution should assess the appropriate threshold scores for AP exams in the same way that they assess courses for articulation.*
2. *AGSC recommends that all state institutions set AP score expectations at “3” for all courses as a means to smooth transfer between state institutions.*
3. *State institutions should clearly report their AP credit awarding thresholds in their institutional materials (web/bulletin/etc.) and AGSC will link to these scores or provide a composite table for easy reference.*

Despite our request for a response from the CCAO, we have not yet received an official reply. The AGSC remains committed to urging both four-year and two-year institutions to adopt a score of “3” for AP credit transfer throughout the state.

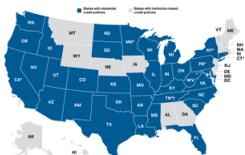
### New AP & CLEP Credit Index Page Made Available on Alabama Transfers Website

In light of this, our staff shifted our focus on how to most effectively present AP credit information on the Alabama Transfers website to better assist students and advisors. Our first step was to create an index (landing page) that links users to the both the AP & CLEP credit policies for all four-year institutions. This index page was recently launched and is being promoted as a new feature on the website. <https://alabamatransfers.com/students/ap-clep-credit-index>



### Ongoing Development of the AP/CLEP Crosswalk Matrix

We have integrated much of the current AP & CLEP information from the index page into our Alabama Transfers database. However, we are still working on the best way to present this information to students to avoid adding to the confusion caused by discrepancies in AP credit transfer. Further development is needed to enhance the layout/functionality of this matrix on our website.

# AGSC: Priority 3 - Update 2023-2024



## Continue work of General Studies Core Sub-Committee with a goal of addressing the following:

- **Identify what general studies should look like in five years**
- **Identify the mission of general studies in Alabama**
- **Identify and address the challenges and/or barriers that prevent action on re-visioning the general studies core**

The Alabama General Studies Committee's (AGSC) Subcommittee on General Education was charged to develop a mission statement for a general education core curriculum and for each of the Areas I-IV. The Committee believed this was a foundational step before further curricular redesign proceeded.

The subcommittee met twice in the past year. First, the 2022-2023 provost survey results were redistributed to subcommittee members to refresh memories of past work, as well as several examples of general education core purpose statements from other states in the U.S. We also noted that the way the Auburn (AU) and University of South Alabama (USA) displayed and described the general studies core was appealing. USA listed the core learning outcomes for each Area, making it clear to students and the public what students would expect to learn from each.

While reviewing the past work, the AA subcommittee had robust discussion of the state of general studies in the state. It was clear from the past survey that most AL colleges and universities had, or were in the process of, redesigned their institution's required core curriculum. Very few were not embarking on the process. The fact that many institutions had, or were considering, general studies redesign was noted to be one barrier that has prevented action on re-visioning the state's current general studies design. The idea of doing a new survey was also considered, to gain more detailed information about each institution's curriculum, especially regarding the use of specific generalized learning outcomes, how the distribution of courses by discipline was approached, whether the sequence was included, and if there had been a change in the number of credit hours required.

In addition, the subcommittee discussed at-length the distributed examples of general education purpose statements. Although these were helpful, the subcommittee was unable to meet a third time to review everyone's suggestions for a mission statement. Nevertheless, the conversations were enlightening and robust. Going forward, this step can be realistically accomplished in first part of the new academic year.

Discussions and decisions remain necessary in the coming year to work toward the priorities listed herein. A barrier to moving forward is the difficulty in making recommendations that will meet the general studies goals of state without significantly disrupting the Alabama Community College System's associate degree requirements and the redesigned work of many institutions. Opinions seemed consistent about not adding more measurement and reporting requirements, for example if specific learning outcomes were added to the current curricular structure.

Finally, a collaborative follow-up meeting was held with UA representatives to update attendees about their work over the summer and any resulting modifications to the new UA Core. At that time (fall 2023), UAs general education redesign still required fewer than the current 41 credit hours, the rationale being that more hours are needed to allow students to declare a minor, without exceeding 120 credit hours for an undergraduate degree. Their model is still in development, and they remain open to further conversations with the AGSC.

# AGSC: Priority 4 - Update 2023-2024



## Begin to evaluate and address possible sequencing issues in Areas II and IV regarding Literature and History.

Recently, our office has received inquiries from advisors and counselors concerning the sequencing issues related to the AGSC policy in Areas II and IV. This policy requires students to complete a sequence in either literature or history, which can affect their course selections in these areas. The consequences of this requirement vary: some disciplines mandate either one or both sequences, while others offer students the flexibility to choose.

### Gathering Feedback from Institutions

To address these issues, we have created an online survey for administrators, registrars, advisors, and counselors to provide the AGSC with input on the current literature/history sequencing policy. The survey has not yet been finalized but a draft of it can be accessed [here](#).



### Current Progress

We are working with ACHE staff, including Robin McGill, to refine and clarify the survey questions. Our aim is to ensure that the survey accurately gathers the feedback necessary for making informed decisions about Areas II and IV. We plan to distribute the survey in Fall 2024 and will report the results to the AGSC at a future meeting. The AGSC will then review this feedback to decide whether to revise the sequencing requirements or maintain the current policy.

# AGSC: Priority 5 - Update 2023-2024



## Work with Alabama Transfers staff to begin to develop a possible succession plan.

### Current Status of the Alabama Transfers Office Staff

As of spring 2024, Alabama Transfers' full-time staff members have each accumulated significant experience in higher education within the state. Both Keith Sessions, the Executive Director, and Shannon Nichols, the Assistant Director/IT Manager, have reached milestones of 30 years of dedicated service to our state's transfer student population. The part-time staff member, Anita Walker, contributes over 35 years of experience. Keith Sessions has dedicated 27 years to Alabama Transfers (formerly STARS), in addition to 1.5 years at Southern Union State Community College and 1.5 years at Auburn University. Shannon Nichols has spent his entire 30-year career with Alabama Transfers. Collectively, the three staff members managing the state's articulation program and implementing policies set by the AGSC bring nearly 95 years of experience to their roles.

### Key Staff Members Preparing for Retirement

Although the staff members are likely 3-5 years away from retirement, it is crucial to begin planning for future staffing needs. Recently, the Succession Plan Sub-Committee convened with the Alabama Transfers team to discuss the need for new hires. This committee is still in the early phases of planning. Following their initial meeting, which included a review of the current and projected budgets, the group requests additional time to formulate a recommendation for the AGSC.

### Looking to the Future

The Executive Director envisions hiring one new staff member in 2024-2025 to focus on marketing, promotion, and training. Additionally, in the subsequent year (2025-2026), contingent on budget availability, another hire is planned to handle support tasks, including website and database maintenance, along with other technical duties. These hires will help ensure a seamless leadership transition and prepare a skilled team to advance the AGSC's goals and the Alabama Transfers office's mission. The Succession Plan Sub-Committee will continue to collaborate with Alabama Transfers staff and will eventually present a formal recommendation to the AGSC regarding the future staffing and direction of the program.

We've collaborated with our web design partners to introduce a new "Real-Time" Usage Report Page. Access to this page is restricted; users must request a username and password from our office. Once access is granted, users can explore the Alabama Transfers usage reports database, which details the number of students submitting official guides. Reports can be filtered by major, sending community college, or target university. Additionally, users can refine their search to specific years or months. Future upgrades will include time-series graphs of submissions, comparisons of submissions versus total page views, and more. # Alabama Transfers System Usage by Community College

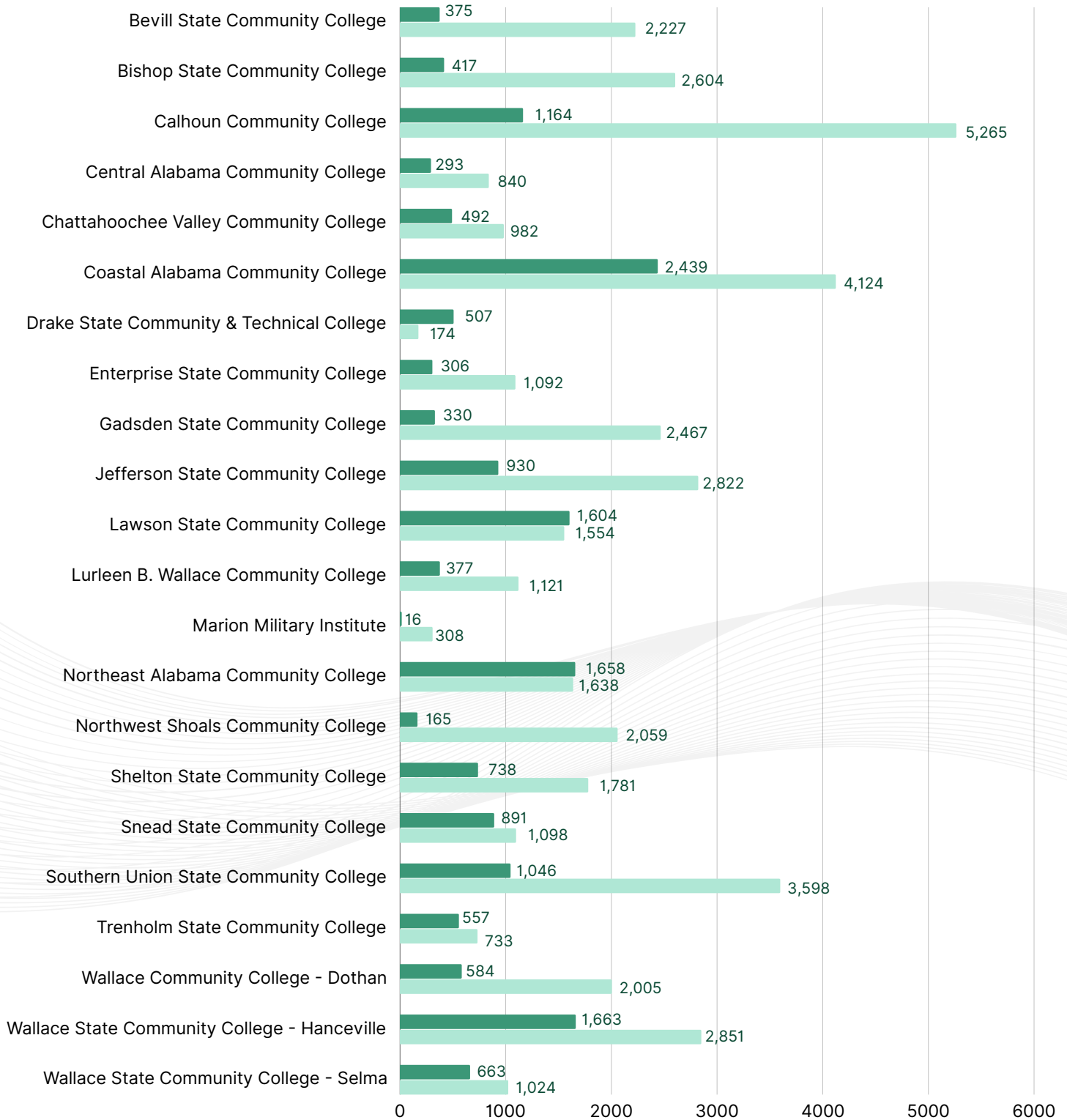
How many community college students have obtained official transfer guides during the year?

FTE 2023 AA/AS Students

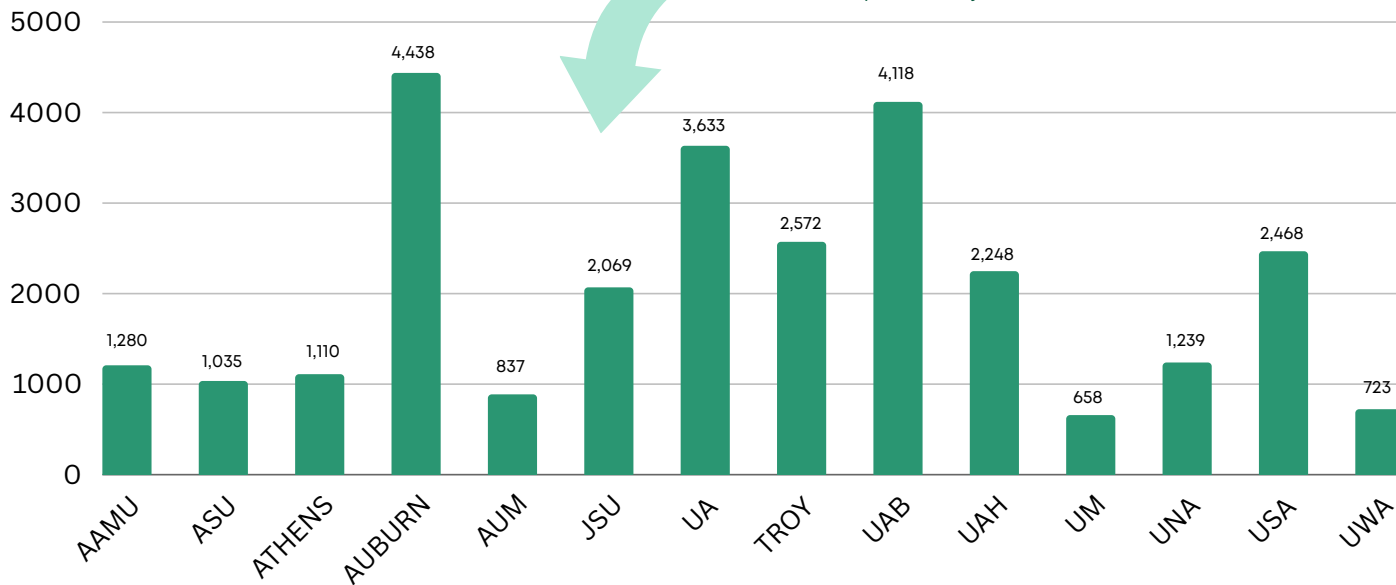

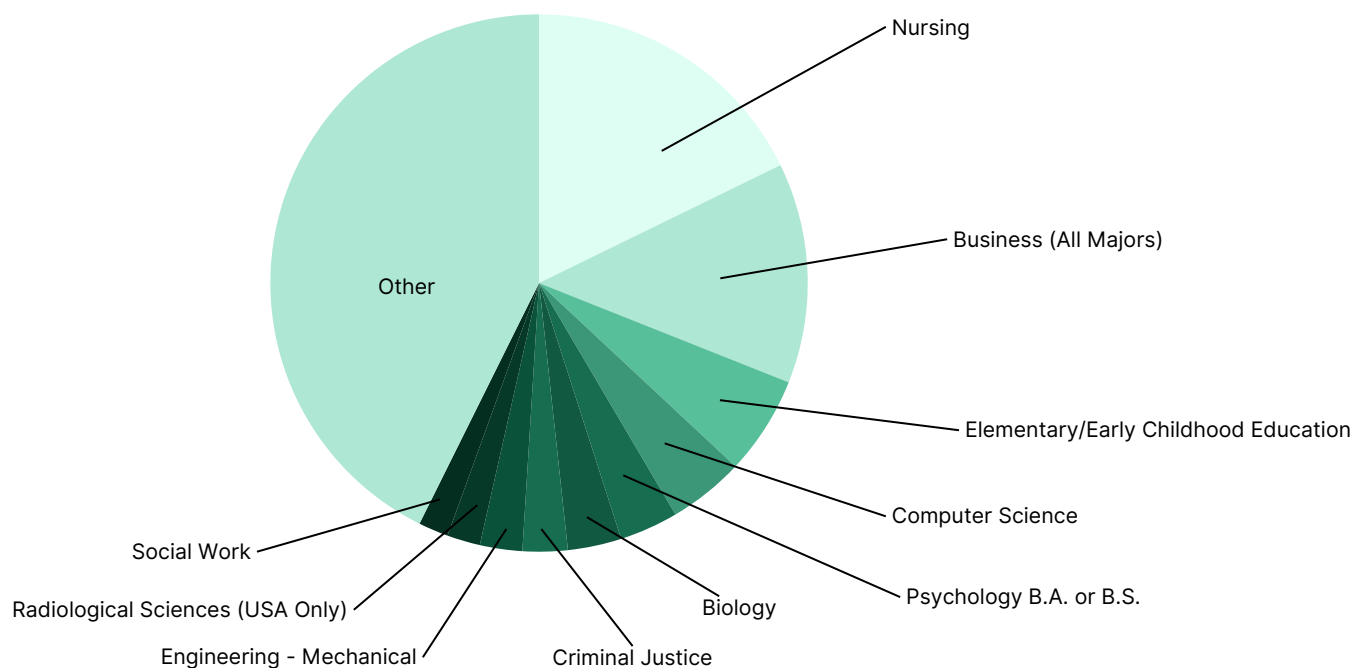

On the new system, they can express interest in or choose as many of the schools that they might be interested in who offer their major. This student usage information is sent automatically to the four-year recruitment email provided by the university and contact between the selected university and the prospective transfer student is usually made within 24 hours. On the old STARS system receiving institutions would not be informed until the first week of each month for the prior month's usage.

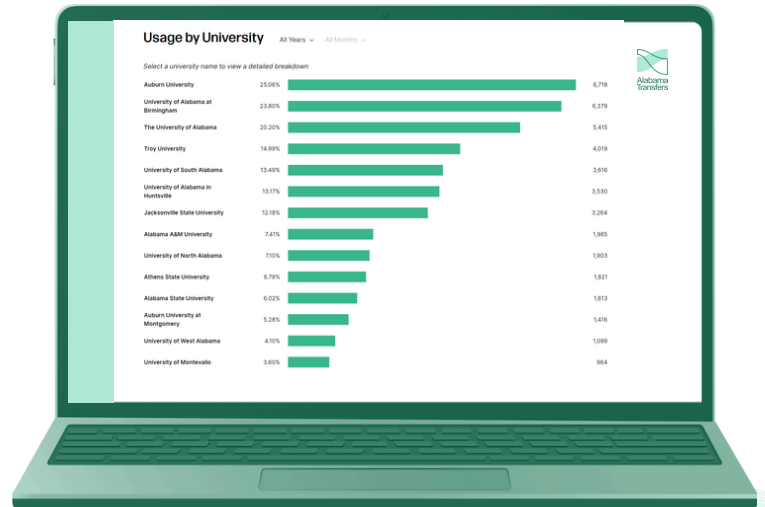

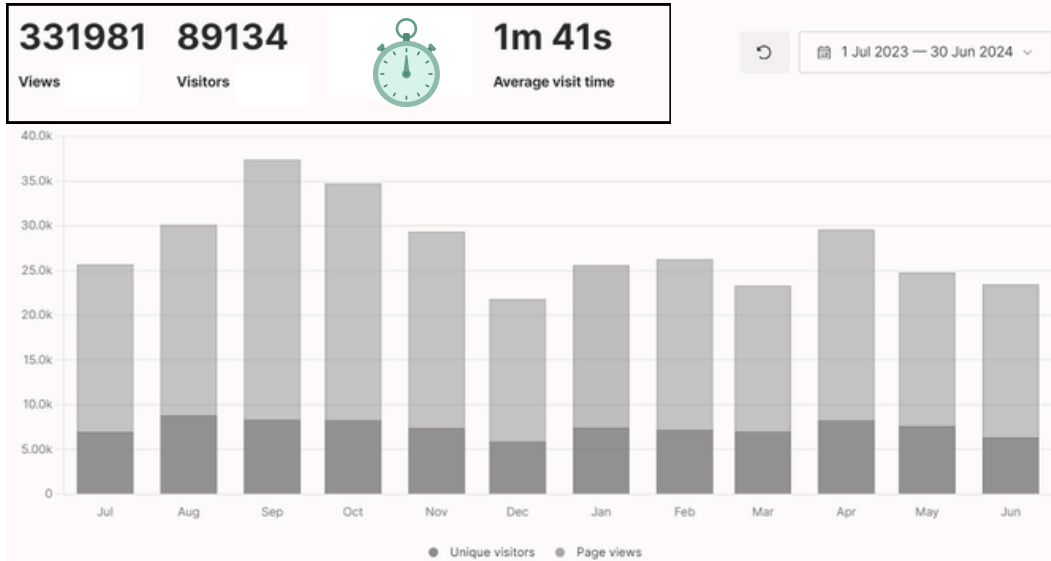

# Looking Forward to 2024-2025



## Setting Priorities & Goals

The Articulation & General Studies Committee (AGSC) and the Alabama Transfers Staff will commit to addressing on the following priorities/goals in 2024-2025:

### **The Alabama Transfers Staff will:**

1. Investigate and research AI technologies to enhance our website, enabling students to upload transcripts via smartphones for real-time “what if” analysis and facilitating reverse transfers for community colleges.
2. Collaborate with the Succession Plan subcommittee to assess future staffing needs for Alabama Transfers, preparing for the upcoming retirement of current leaders.
3. Continue efforts to market, promote, and educate students, counselors, advisors, faculty, and administrators throughout Alabama, aiming to boost the adoption and effective use of new technologies on the Alabama Transfers website.

### **The AGSC Membership will:**

1. Persist in the efforts of the Gen Ed subcommittee to address issues aiming to clarify the mission of general education in Alabama and to enhance the existing AGSC general education framework. Also, continue to address possible issues or problems associated with the current literature and history sequencing requirements in Area II and Area IV.
2. Continue the work of the Succession Plan subcommittee to evaluate future staffing needs for Alabama Transfers and present recommendations to the AGSC regarding a potential succession plan.
3. Host the 7th Annual Achieve Conference.
4. Advance the review of AP/CLEP credit in an effort to encourage the Council of Chief Academic Officers to reconsider and respond to the AGSC's 2021 recommendations (accepting a AP score of 3 for across the board).
5. Examine the impact of the Numeracy Act on Elementary/Early Childhood Education and its potential effects on the transfer credit for math courses in Area V.
6. Provide guidance on the utilization and spending of all discretionary funding.



# Alabama Articulation Legislation



# Alabama Articulation Legislation: Act 94-202



The computerized advisement system for students operated by Troy State University which includes a comprehensive undergraduate program and course information for all public two-year and four-year institutions of higher education, existing on the effective date of this amendatory act, shall ensure students at each two-year institution accredited by the Southern Association's Commissions on Colleges, the opportunity to enter into a contract with a four-year institution guaranteeing the transfer of credit earned for courses taken at the two-year institution pursuant to the terms of the contract provided the student is admitted to the four-year institution. Under this contract, all agreed upon credits transferred from a two-year institution to a four-year institution shall fulfill degree requirements at the four-year institution as if they were earned at the four-year institution. Information regarding this advisement and contracting program shall be included in the official catalog of each institution of higher education. All public two-year and four-year institutions in the state accredited by the Commission on Colleges shall participate in this system.

"In addition, there is created an articulation and general studies committee which shall consist of ten members composed as follows: two representing the state's regional universities, three representing the state's two-year colleges (one of whom shall be black), one representing each of the following: Auburn University, the University of Alabama System, the University of South Alabama, Alabama State University, and Alabama A&M University. The Executive Director of the Alabama Commission on Higher Education and the Director of the computerized advising system operated by Troy State University shall serve as nonvoting members.

"Unless provided by the governing board of the respective institution, the representatives to the articulation and general studies committee shall be selected in the following manner: The presidents of the state's regional universities shall select the two representatives of these institutions on the committee. The State Board of Education\* shall select the representatives of the state's two-year colleges on the committee. The Chancellor of the University of Alabama System and the Presidents of Auburn University, the University of South Alabama, Alabama State University, and Alabama A&M University shall each select the representative of their institutions on the committee. It is the intent of the Legislature that women be represented on the committee. This committee, utilizing whatever resources and task forces it deems appropriate, shall develop no later than September 1, 1998, a statewide freshman and sophomore level general studies curriculum to be taken at all colleges and universities. Nothing herein shall be interpreted as restricting any institution from requiring additional general studies courses beyond the statewide general studies curriculum.

"This committee shall also develop and adopt no later than September 1, 1999, for the freshman and sophomore years, a statewide articulation agreement for the transfer of credit among all public institutions of higher education. Under this articulation agreement, all applicable credits transferred from a two-year institution to a four-year institution shall fulfill degree requirements at the four-year institution as if they were earned at the four-year institution. The committee shall further examine the need for a uniform course numbering system, course titles, and descriptions.

"A four-fifths vote of the entire voting membership of the committee shall be required for the adoption of the articulation agreement and general studies curriculum. Upon adoption of the articulation agreement and general studies curriculum, this committee shall continue its duty and authority prescribed herein. The committee shall meet at least annually, or at other times as convened by the chair. The committee shall elect annually a chair from its membership. The chair of the committee shall rotate annually between a representative of the four-year institutions and a representative of the two-year institutions.

"In case of problems in the administration or interpretation of the articulation agreement or the general studies curriculum, institutions shall present the problem to the articulation and general studies committee for resolution. A majority decision of the committee shall be final and binding.
