ADOPTION OF AGENDA	Dr. Fulmer moved for the adoption of the agenda with the addition of discussion on Advanced Placement credit. Dr. Riedel seconded. The agenda was adopted as amended.		
APPROVAL OF MINUTES	Dr. Riedel moved for the approval of the April 21, 2016 minutes. Dr. Relihan seconded. Minutes were approved.		
NEWLY APPOINTED MEMBERS	Dr. David Campbell, President, Northeast Alabama Community College, is the new representative appointed to the AGSC by the Alabama Community College System.		
ELECTION OF VICE- CHAIR	Dr. Campbell moved to nominate Dr. Riedel as AGSC Vice- Chair for 2016-17. Dr. Williams seconded. There were no other nominations. Motion carried.

COMMENTS FROM INCOMING CHAIR	Dr. Ozment stated that she appreciates being able to serve as AGSC Chair and looks forward to the coming year. She stated that the AGSC may be meeting at least one more time in the fall since the evaluation may call for an intense workload. She thanked Dr. Crawford for his chairmanship and his ability to move meetings forward.		

### **DECISION ITEMS**

#### **Executive Director's Report**

AGSC/STARS Annual Report. This item was tabled until the completion of the Evaluation Report.

Dr. French reminded the AGSC that the AGSC/STARS Annual Report cannot be completed until certain issues are addressed from the recommendations of the Evaluation Report.

<u>AGSC/STARS Goals & Priorities for 2016-17</u>. This item was tabled until the completion of the Evaluation Report.

AGSC/STARS Budget. Dr. Sessions presented the 2016-17 budget (copy attached #3).

After lengthy discussion regarding the layout of the budget, Dr. Relihan moved to approve the budget with the correction of \$0 in the medical insurance line. Dr. Riedel seconded. Motion passed.

<u>STARS Usage Reports</u>. Nichols stated that usage is down, however; the unofficial usage is at its highest due to students browsing the system before getting an official guide. A copy of the June-July 2016 usage reports are attached - #2.

He stated that regular reports are available in addition to annual reports where usage is recorded by institution, month, and major.

### ACADEMIC COMMITTEES

<u>Ratification of Templates</u>. Drs. Sessions and Nash presented the following institution specific templates for ratification as recommended by the Chief Academic Officers (CAOs) (copies are attached-#4):

<u>Jacksonville State University</u>: Applied Manufacturing Engineering Applied Electronics Engineering Occupational Safety & Health Management There was lengthy discussion regarding reducing the hours required in Areas I-IV to meet ABET requirements. There was also concern from AGSC members that caution should be taken in allowing various accreditation agencies to drive the general studies curriculum.

Dr. Ozment moved that the AGSC have more discussion on this issue and that the JSU templates be tabled for further clarification. Dr. Jones seconded. Motion passed.

Alabama State University Forensic Chemistry Forensic Biology

Dr. Relihan moved for ratification with the amendment of listing the correct title for course number 106 in Area V and course number 107 as Public Speaking. Dr. Ozment seconded. Motion passed.

<u>University of South Alabama</u> Instructional Design & Performance Improvement

Adams moved for ratification. Fulmer seconded. Motion passed.

<u>University of Montevallo</u> Environmental Studies, B.A. & B.S.

Dr. Jones moved for ratification with the amendment of adding the Biology sequence 103 and 104 in Area III and making the adjustment of an additional science if needed. Dr. Adams seconded. Motion passed.

There was discussion initiated by Dr. Nash regarding the signatures required on templates. It was revealed that institution only templates do not go to academic committees for approval. The current signature line requires a signature from either the Academic Committee Chair or the Department Chair from the institution.

Further discussion resulted in the following recommendations from AGSC members:

- 1. Templates include the total number of elective hours, total number of hours in the major, and the total number of hours to complete the degree. (*Dr. Ozment*)
- 2. That a subcommittee be appointed following the completion of the Evaluation Report to address issues related to the Academic Committees. Issues would include AGSC practices, forms required, etc. and made a priority in the AGSC Annual Report. (*Dr. Relihan*)
- 3. Consider AGSC approval of programs before they go to ACHE. (Dr. Relihan)
- 4. Incorporate "best practices" to be reviewed every five years. (Dr. Adams)

<u>Reverse Transfer Update</u>. Dr. Crawford reported that Dr. Russ Rothamer, Chief Academic Officer, Alabama Community College System (ACCS), is overseeing the reverse transfer project. A draft of the reverse transfer MOU was distributed to two-year and four-year institutions on May 31, 2016. Feedback on the draft has been incorporated and a new MOU will be distributed. Wednesday, September 14, 2016 is the tentative signing day of the MOU following the ACCS Board meeting. A copy of the MOU is attached #5. The National Clearinghouse will manage the system.

### OTHER

<u>Advanced Placement (AP) Scores</u>. Dr. Nash stated that some institutions in Alabama accept a score of 3 on advanced placement programs. Other institutions will only accept a score of 4 or 5. Since the acceptance of scores vary, the question to the AGSC is whether the AP score should be the same statewide.

Dr. Nash stated that he planned to add the subject of AP scores to the fall joint meeting of the Chief Academic Officers and the two-year instructional officers.
