CALL IO ONDEN	The regular meeting of the Articulation and General Studies Committee was called to order at 10:15 a.m. There was no quorum determined by roll call of members present.
NEWLY APPOINTED	Dr. Russ Rothamer, Chief Academic and Student Affairs Officer, Alabama Community College System will replace Dr. Mark Heinrich as alternate for the two-year system.

<u>AGSC/STARS Evaluation Report</u>. Dr. Katsinas presented the Executive Summary of the evaluation report which incorporated suggestions from the subcommittee meeting on August 25, 2016 including a section on key findings.

After extensive discussion, it was determined that due to the absence of congruity between the two Executive Summary and the body of the final report circulated on September 1, 2016, additional changes would be necessary prior to presenting the findings and recommendations to the Commission. It was decided to withdraw the item from the Commission's September agenda.

The AGSC members elected to assign one person (Dr. Elizabeth French) to work with Dr. Katsinas on incorporating the changes that were recommended by AGSC members and the development of an executive summary. Dr. Ozment appointed a subcommittee (Fulmer, Relihan, Riedel, Rothamer, and Williams) charged with conducting an in-depth analysis of the evaluation report and developing an implementation plan for the AGSC to consider. Dr. Sessions was requested to provide the subcommittee with an estimate of funds needed to implement Recommendation No. 3: Building upon the insight that students use STARS to "shop," improve STARS' web-based services by making them accessible on mobile platforms.
