Call to Order	The meeting of the Articulation and General Studies committee was called to order by Dr. Eva Lewis at 1:03 p.m. A quorum was determined by roll call of members present.
Adoption of Agenda	Dr. Fulmer moved for the adoption of the agenda. Dr. Wehlburg seconded. The agenda was adopted.

Approval of Minutes	Dr. Fulmer moved for the approval of the February 15, 2024 minutes with a correction in the spelling of Dr. Sessions last name. Dr. Wehlburg seconded. Minutes were approved.

# New ACCS Mathematics Non-STEM Pathway Course in Pilot Phase (MTH 108 - Quantitative Reasoning)

Dr. Sessions introduced Dr. Chantae Calhoun to discuss with the committee the new non-STEM math course.

Dr. Calhoun shared some background and current status of a new course developed by the community college system. The creation of the new math course would provide students in the non-STEM majors another option rather than Finite Math or Precalculus Algebra. The course has been added to the ACCS course directory, but the course is not available to all colleges. The course will be taught at select colleges as a pilot program in the Fall 2024. ACCS would like feedback from the universities. This course may come to the committee in the future for approval, and if approved, the course will be added to all appropriate transfer guides as a math course option in Area III.

Dr. Sessions stated he will send the course information to the universities for feedback in which questions should include responses on course objective and learning outcomes to make sure the course is not overlapping on other courses being offered.

Dr. Bristol mentioned the math course is not on the state's approved list for education certification requirements. She stated that each institution, if they wanted to adopt this course, would have to submit every checklist in order for the course to be considered as an option.

Dr. Coleman mentioned concerns that her math chair and coordinator have with the course. The question posed was: Does the course include the use of spreadsheet software Excel training because during previous discussions, it was an important part of the quantitative reasoning math course? Dr. Calhoun stated she would seek more clarification.

# Math Pathways Presentation – The Dana Center & Alabama A&M University

Dr. McGill shared background information on the presenters from the Dana Center and Alabama A&M University.

Dr. Kadhi discussed the background of the Alabama A&M Math pathways. He also discussed challenges with college algebra and alternative paths for students beyond calculus. Dr. Kadhi talked about new quantitative reasoning and data pathway courses being considered, and the challenges with transferring credits to other institutions. The new pathway courses will be launched in Fall 2024. They will collect and analyze Fall 2024 data of the DFW rates in the core math courses and report, comparing and contrasting the findings by midsemester Spring 2025.

Dr. Savina discussed the misalignment of math courses that were designed in the past, such as algebra and pre-calculus, and how more statistics and quantitative reasonings is now needed. He talked about his current work for the Gateway Level Math project. He also addressed the current curriculum, in which only 20% of majors require calculus, and how more majors require statistics, quantitative reasoning, and data science. He indicated the importance of a state task force to address misalignment in education.

#### Q and A:

Dr. Lewis asked how do these non-STEM courses that do not require calculus help students to understand the economy? Dr. Savina response was statistics is a substitute course, and it plays a vital role in understanding the world and the way we sample data.

Dr. Sessions stated he would share the work the AGSC subcommittee compiled from research and surveys, which indicate the need to open the math pathways to include statistics and quantitative reasonings courses in Alabama.

Dr. Calhoun asked Dr. Kadhi to connect with ACCS math facilitator to compare the quantitative reasoning course that both ACCS and Alabama A&M University have developed.
