## I. GEO 102 Principles of Physical Geography II—4 Semester Hours

## **II.** Course Description

Physical Geography II is the second course in a two-part sequence. Topics focus on the Earth's surface and internal processes and how the processes affect landforms, water resources, soil, and vegetation of the earth. Laboratory is required.

## V. Course Learning Outcomes

Upon successful completion of the course, the student will demonstrate the following outcomes:

- 1. Explain the spatial distribution of volcanoes and earthquakes and the threats that they pose to human life.
- 2. Describe the processes associated with aggradation and denudation.
- 3. Identify landforms created through erosion and deposition.
- 4. Discuss the current and future threats faced along coastlines.
