Hello Dr. Ross. Please discard the memo/letter I sent to you on November 29, 2022. We now need **TWO new regional members** to be appointed to the AGSC. These appointments are to be made by the Council of Presidents according to state law. The Alabama Articulation and General Studies Committee was created by state law in 1994. Within the legislation, the committee makeup includes 2 voting (and 2 alternates) from the regional institutions. The following institutions are considered to be regional universities.

- Athens State University
- Jacksonville State University
- Troy University
- University of Montevallo
- University of North Alabama
- University of West Alabama

Currently, the regional voting members and alternates are as follows:

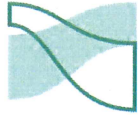
